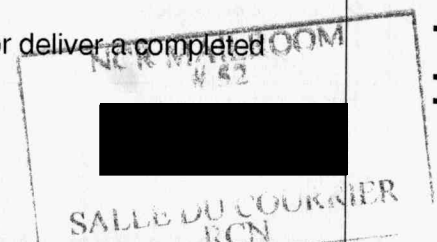

For spoiled receipts, the recipient must return the spoiled receipt to us. The receipt is voided, and a new one issued.

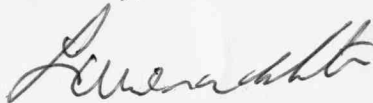

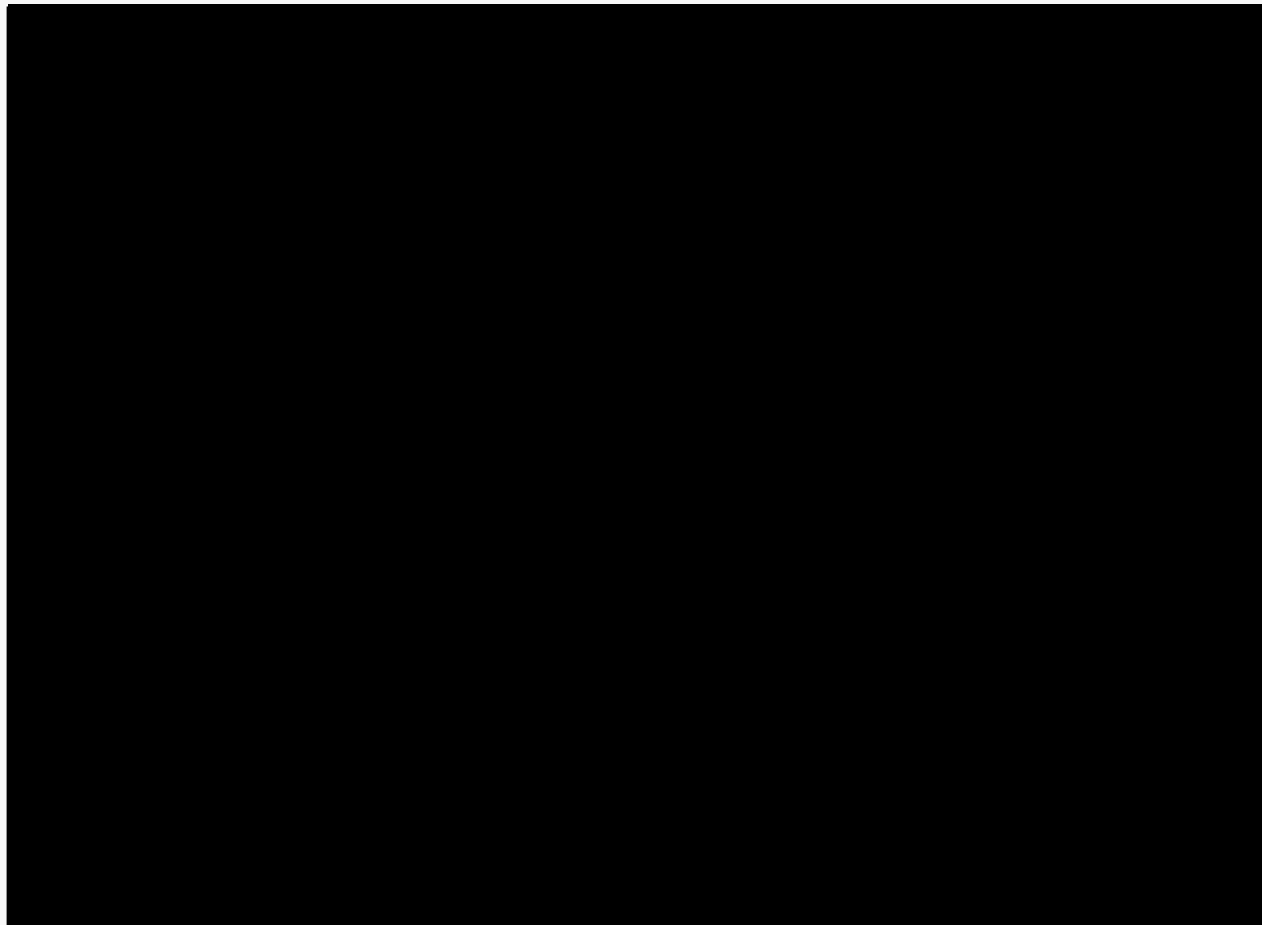
