The Charity, in turn, directed \$114 million

of the cash and property to two other registered charities also participating in these arrangements. The audit revealed that the vast majority of the cash sent to the other participant charities was subsequently paid to the promoters. Of the remainder, the Charity itself paid \$33 million in fundraising fees to the tax shelter promoters and retained, but did not disburse, \$21 million in net assets. In fact, it appears that beyond these transfers (i.e., those that the Charity is directed to make by the tax shelter promoters), the Charity has only made a single \$2,200 gift to another qualified donee." Just kidding with that performance they will probably only get a bronze!
