Objects and Statement of Proposed Activities

Object:

- 1. To establish and to promote programs and activities that reduce the poverty and exploitation of children throughout the world and that relieve the conditions of exploited children.**

Activities:

- (I) To promote and foster programs to remove children from circumstances of exploitation.
- (ii) To establish and sponsor programs, activities and enterprises to relieve the conditions of exploited children, including programs to relieve hunger, to provide primary education and to educate children and their communities on how to avoid exploitation.

For example:

- a) In collaboration with the [REDACTED] and its agent, Mr. [REDACTED] for his work with children in bonded labour), build, staff and finance a live-in rehabilitation/education centre for children who are freed bonded labourers. The centre will help children freed from carpet factories and other hazardous industries in India readjust to society and overcome physical and psychological abuse. The children will be provided with instruction in reading and writing and vocational skills.
- b) In collaboration with the [REDACTED] and its agent, Mr. [REDACTED] establish four rural schools in India for children freed from labour in hazardous industries. The schools will provide the children with basic education, rehabilitation and health care, as well as food for themselves and their families, helping the children and the communities to break the cycle of poverty and child exploitation.

(See our letter dated December 20, 1996 for further details on these foreign activities and for a precedent form of sample agency agreement.)
- c) Similar projects will be established and/or sponsored in other countries in collaboration with grass-roots organizations, as appropriate to the local situation.

- (iii) To establish infrastructures to help to create links between Canadian children and their peers around the world in order that they may participate in and contribute their talents and skills towards projects that help to relieve the suffering and poverty of children of the world.

For example:


In spring 1996, Free The Children set up two relief projects in which school children in the Toronto area collected school supplies. One was for a rehabilitation centre for 65 girls, most of whom were former restaveks (domestic slaves) in Haiti:

Foyer des Filles de Dieu



And the other was for a schooling program for street children in Bangkok, Thailand:

Father Joseph H. Maier
Human Development Centre



Similar contracts are being made in Brazil and South Africa between children in Canada and children in need in these countries.

Object:

2. **To establish and to promote programs and activities that will provide skills in leadership and citizenship training to children in Canada, to better equip them to participate more fully as youth representatives, as volunteers and as responsible citizens on a local, national and international level.**

Activities:

- (I) To establish and to promote workshops and youth conferences to teach young people leadership skills, skills in public speaking, teamwork, group dynamics and organizational skills, which will lead to the development of the skills, self-confidence and self-esteem necessary to assume leadership roles.
- (ii) To develop and distribute a "how-to-kid's guide" in order to volunteer in service projects on a local, national and international level.

- (iii) To work with schools to help give children skills to learn more about international development issues and methods by which they can participate to relieve the poverty and exploitation of children, through:
- a) training and providing youth leaders as speakers and role models for children in schools by highlighting the accomplishments of children who have contributed to the relief of poverty and exploitation among their global peers by taking action in Canada;
 - b) helping children to acquire computer skills and Internet training necessary to do research and communicate with other children around the world;
 - c) creating a link between children in Canada and those of other countries through the promotion of exchange of letters, gathering of needed supplies (e.g. school supplies) and educational youth exchanges (e.g. two young people from Free The Children will be visiting [REDACTED], a rehabilitation centre for freed bonded labourers as guests of [REDACTED] in India this summer; two representatives of Free The Children recently returned from Sweden where they shared ideas on children's issues with students in schools).

Schedule A

Example of Typical Training Weekend for Children

Friday Evening: “Establishing rules and getting to know you”

Skills building Session One:

Key Concepts - Basis of leadership - Establishing Goals

Basis of leadership - Establishing basic rules of respect when working with people

- Be Positive - Every session has a purpose
- Speaker in charge:
 - Allow people time to express themselves and their ideas
 - Don't rush people because the speaker is in charge
 - Finishing off other people's sentences is a no-no
- Speak for yourself:
 - Speak for yourself and what you believe
 - Don't include others in your assumptions
- Right to Pass
 - Don't push people to say or to do more than they want to
 - Respect other people's right to pass or to quit
- Avoid killer sentence - A killer sentence is anything that makes people feel badly
- Level out - Don't consider yourself above anyone else in the crowd - Everyone is equal
- Don't play the role - Be proud of who you are while respecting the individuality of everyone else.

Opening Sessions

Activity One: Name association - Games of introduction

Activity Two: Group Cheer - Working as a group on a cheer to discover real leaders, creative geniuses, etc.

Activity Three: - Conference Goals

- Exchange of ideas
- Skill workshops offered for weekend

Saturday (AM and PM)

Skill session workshops of skills described in the letter public speaking, use of Internet, Group dynamics, how to run a meeting, record keeping, etc. The services of professionals will be sought in the setting up of these workshops.

Sunday (AM)

- Inspirational Speaker
- Skills: Choosing an area of involvement in the community
 - How to find information, resources, areas to volunteer using the Internet, telephone directories, research, expressing and organizing thoughts in writing
 - Hands on activities for skills building
 - Organizing a project - group work - review and evaluation - role playing
- Day Workshops - Skill building would concentrate in a specific area (i.e. Computer training)
