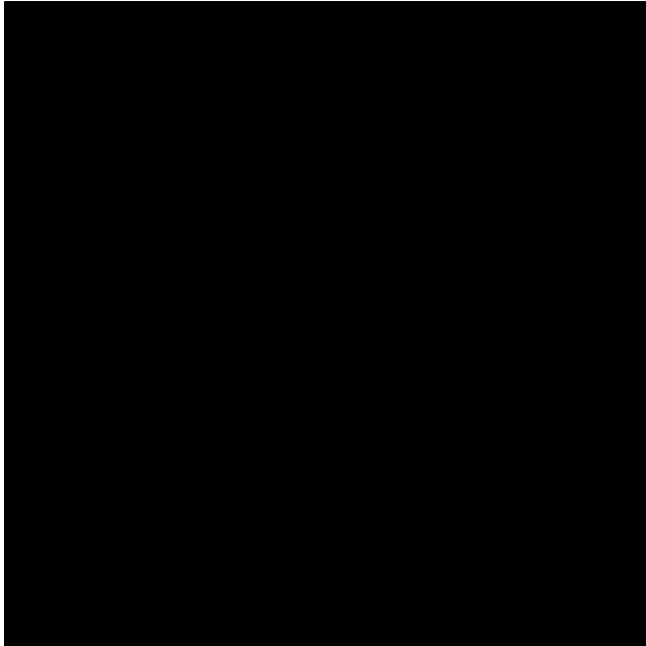

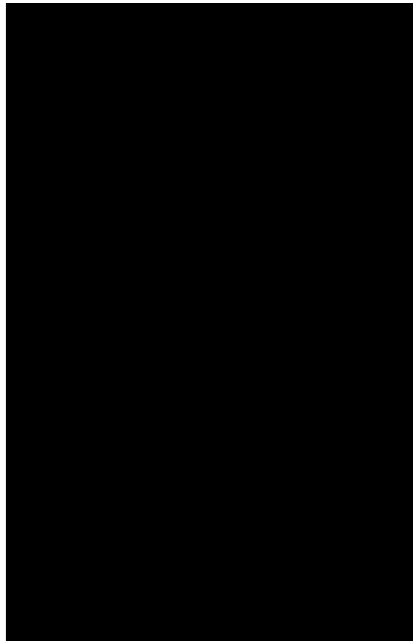

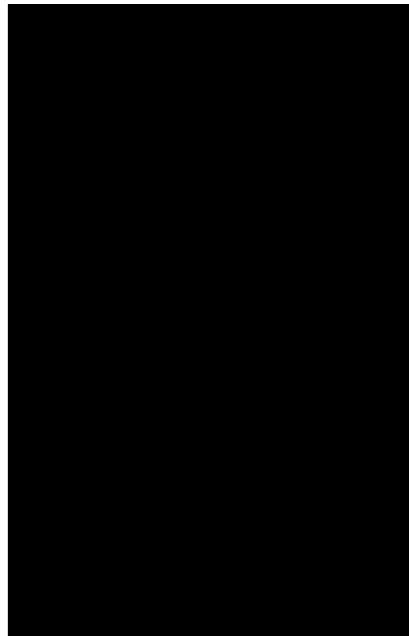

**US INVESTMENTS - Canadian Dollar Equivalent**




