IF A CONFLICT OF INTEREST IS IDENTIFIED THE SOCIETY WILL TAKE THE NECESSARY PRECAUTIONARY MEASURES TO ENSURE THAT THE BEST INTERESTS OF THE ORGANIZATION ARE SAFEGUARDED.

THE COMPENSATION PROCEDURE FOR THE REMAINDER OF THE OFFICER CLASS FOLLOWS A SIMILAR PROCESS WITH THE CEO UTILIZING EXTERNALLY PREPARED COMPENSATION SURVEY AND OTHER MARKET DATA TO ARRIVE AT FAIR COMPENSATION BENCHMARKS FOR NEWLY RECRUITED OFFICER LEVEL STAFF.
