In 2022, MWLT continues to fulfill our mission with a portfolio of lands for future acquisition that would include a diversity of ecological habitats worth conserving. MLWT secured an additional 38 acres of land to its conservation land protection portfolio.

The Magnetawan Watershed Land Trust continues to steward its property and easement. We maintain our hiking trails, check boundaries and the easement restrictions are followed.

The Magnetawan Watershed Land Trust ("MWLT") provides environmental education opportunities. In 2022, MWLT offered two online presentations and one nature hike. We provided nature article to the Almaguin newspaper and the Great North Arrow, and produced a regularly published newsletter with over 400 people subscribing.
