Toronto Metropolitan University (TMU) is a leading institution of innovation and entrepreneurship that responds to societal need through high-quality, professional, and career-related bachelor, master's, and doctoral programs, and relevant scholarly, research, and creative activities. In 2023, it awarded 7,723 bachelor's degrees, 159 law degrees, 1,139 master's degrees, 79 professional master's diplomas, and 86 doctoral degrees. Overall student enrolment in the 2022-23 academic year was 46,462 (39,500 FTE) and the university achieved over CAD \$90 million in research funding.
