In the spring and fall, school groups participate in five-day voyages to the Gulf Islands of southern BC. In the summer, ten-day voyages collectively circumnavigate Vancouver Island. Young trainees are involved in every aspect of sailing the ship, including navigation, sail handling, pilotage, bow watch, cleanup etc. They receive formal sail training instruction and complete exams. They participate in group discussions about life issues. The program helps young people learn to live in community, develop a strong work ethic, understand teamwork, grow spiritually, learn to resolve problems and conflicts, and understand other cultures.
