In 2022 the SDIA office published five eNewsletters in three languages which focussed on inviting our community to visit two projects through our SD Passport Sessions (Human Force and FUEGOS), providing updates about Ukraine's situation, our Chairman's passing, sharing our 2021 Annual Report and some highlights of our 2022 AGM. We also introduced two new members that joined our network, Subud Indonesia and Ransel Buku, and produced two fundraising campaigns, one of which was an emergency appeal for Ukraine. On-going communications included updating the website www.susiladharma.org and maintaining and expanding our online presence via Facebook and Instagram. Building Capacity : Through connections, collaboration, and knowledge sharing, each member organization of SDIA can build capacity in key areas identified for sustainable futures: education, health, livelihoods, and environment.
