ITS PRIMARY MISSION IS TO DEVELOP RESEARCH AND OFFER GRADUATE AND UNDERGRADUATE EDUCATION. THERE ARE 7 FACULTIES SINCE INCEPTION OF THE UNIVERSITY NAMED FACULTY OF BUSINESS AND INFORMATION TECHNOLOGY, FACULTY OF EDUCATION, FACULTY OF ENERGY SYSTEMS AND NUCLEAR SCIENCE, FACULTY OF ENGINEERING AND APPLIED SCIENCE, FACULTY OF SCIENCE, FACULTY OF HEALTH SCIENCES, AND FACULTY OF SOCIAL SCIENCE AND HUMANITIES. THE TOTAL STUDENT HEADCOUNT IN THE FISCAL YEAR ENDING MARCH 31, 2023 IS 11,054 (OR 9,555 FTE). THE LARGEST FACULTY IS THE FACULTY OF ENGINEERING AND APPLIED SCIENCE.
