THE WELLSPRING FOUNDATION HAS SUPPORTED 182 SCHOOLS, EQUIPPED 274 LEADERS, IMPACTED 484 COMMUNITIES, EMPOWERED 3,576 TEACHERS, AND WORKED TOWARD A BRIGHTER FUTURE FOR 205,024 STUDENTS. OUR HALLMARK PROGRAM, THE SCHOOL DEVELOPMENT PROGRAM, CONTINUES TO SERVE STUDENTS, TEACHERS, SCHOOL LEADERS, PARENTS AND COMMUNITY REPRESENTATIVES. DATA FROM THE GOVERNMENT OF RWANDA ABOUT DOMESTIC CONFLICT HAS LED US TO REFINE SDP MODULES TO REFLECT OUR SUPPORT FOR HEALTHY FAMILIES THAT WILL ENCOURAGE HEALTHY LEARNING AMONG CHILDREN. THROUGH THE SCHOOL DEVELOPMENT PROGRAM, WE HAVE ALSO APPLIED OUR KNOWLEDGE AND EXPERIENCE TO A BLENDED DIGITAL LEARNING APPROACH; THIS APPROACH, USING VIDEOBASED RESOURCES, ENABLES TEACHERS (ESPECIALLY FEMALE TEACHERS IN REMOTE AREAS) TO ACCESS INSERVICE PROFESSIONAL DEVELOPMENT WITHOUT LEAVING THEIR FAMILIES BEHIND TO ATTEND MULTIDAY CENTRAL TRAINING. WE CONTINUE TO PROVIDE SDP TRAINING TO AROUND FIFTEEN SCHOOLS IN THE RAKAI DISTRICT OF UGANDA. WE HAVE INCREASED OUR FOCUS ON SOCIOEMOTIONAL LEARNING FOR STUDENTS AT 55 SCHOOLS IN SEVEN DISTRICTS DURING THEIR FIRST YEAR OF SECONDARY SCHOOL THROUGH THE YOUTH FIRST PROGRAM.THE ORGANIZATION ALSO PROVIDES SUPPORT FOR THE PRIVATE WELLSPRING ACADEMY IN KIGALI, COORDINATES ACTIVITIES IN PARTNERSHIP WITH OTHER EDUCATION-FOCUSED NGOS, AND SUPPORTS THE DEVELOPMENT STRATEGY, CURRICULUM AND TEACHER TRAINING ALONGSIDE RWANDA'S MINISTRY OF EDUCATION.
