The Restoration and Regeneration Program ensures that WWF-Canada's restoration actions result in new and increased storage of carbon in natural land freshwater and shoreline ecosystems while supporting an increase in the amount of viable sustained habitat. The program will also be a central driver of making it possible for millions of residents to take measurable actions for conservations.
