1 Introduction

1.1 About this document

The purpose of this document is to describe the public data of Form T3010 available on the Open Data website (open.canada.ca). This data dictionary covers registered charity information returns with a The month and day of the charity's fiscal year end. Charities must file their annual Form T3010 within six months of their fiscal year-end date that falls within the **2013 – 2022** calendar years.

To reduce the administrative burden on charities, the Canada Revenue Agency (CRA) is modernizing its information technology (IT) systems to provide new digital service options.

In May 2019, the Charities Directorate made several digital services available as part of this initiative:

- Form T2050, Application to Register a Charity under the Income Tax Act, was replaced by a new online application for registration.
- Registered charities can complete and file their T3010 Registered Charity Information Return online through CRA's My Business Account.
- Charities can update their organization's information online and correspond with the Directorate electronically through My Business Account.

Form that registered charities must fill out annually and send to CRA within six months of the end of its fiscal period. A charity uses this form to report its activities, sources of revenue, and expenditures.
- [T1235 \(year in question\) – Directors/Trustees and Like Officials Worksheet](#) Form used by a registered charity to identify its board of directors/trustees and like officials. Every charity must submit this form as part of its annual return.
- [T1236 \(year in question\) – Qualified Donees Worksheet/Amounts Provided to Other Organizations](#)
Form used by a registered charity to identify the gifts it made to qualified donees and other organizations during a fiscal year. Every charity must submit this form as part of its annual return.
- [T1441\(year in question\) - Qualifying disbursements: Grants to non-qualified donees \(grantees\)](#)
Form used by a registered charity to identify the qualifying disbursements to non-qualified Donees during a fiscal year. Every charity must submit this form as part of its annual return.
- [TF725 – Registered Charity Basic Information Sheet \(BIS\)](#)
A pre-printed form that was mailed to registered charities in the month following their The month and day of the charity's fiscal year end. Charities must file their annual Form T3010 within six months of their fiscal year-end.as part of their T3010 information return package.

NOTE: As of May 2019, the BIS is no longer mailed to charities.


